Assessment of Fine for Late Filing

Dear Mr. Petersen:

It has been determined that it is necessary, pursuant to Florida Statute 106.07, to assess a fine for delinquent filing of Campaign Treasurer's Report, due 10-10-03. The original report was received on 10-16-03 and was postmarked by United States Postal Service on 10-15-03. The fine is assessed as follows:

- A. Campaign Treasurer's Report, herein known as Q3, was due on October 10, 2003 by 5:00 p.m. or appropriately post-marked 10-10-03 by the United States Postal Service. The period covered by Q3 was (07-01-03 through 09-30-03). Based on FS 106.07, the fine is assessed as follows: \$50.00 for each day late for the first 3 days and \$500.00 for each day thereafter not to exceed 25% of total receipts or expenditures, whichever is greater, for the period covered by the late report. In compliance with FS 106.07 the fine assessed for Q3 is \$ 1,150.00, based on a five-day late report.

You were contacted, by telephone, regarding the late, incomplete Q3 report on 10-14-03. We are unable to calculate a fine based on either contributions or expenditures for the reporting period covered by the Q3 report, because the report is incomplete, therefore, the fine is based on number of days late until you appear in person and bring all information pertaining to the Q3 report. It is possible that the re-calculated fine will be less. Our office cannot make that determination until the committee provides our office with a complete Q3 campaign treasurer's report.

The fine may be paid, from committee funds, and must be paid within 20 days of receipt of this notice unless an appeal is made to the Florida Election Commission within the statutory 20-day time period provided in Chapter 106.

Please refer to the copy of Florida Statutes Chapter 106 or the Political Committee Handbook that the committee was provided with when it established itself as a political action committee in Lee County.

Your cooperation and timeliness in this matter would be greatly appreciated. If you have any questions, please call me at 339-6304. Failure to comply with your obligation to file a complete campaign treasurer's report and pay any corresponding fines will result in your file being turned over to the Florida Election Commission for further examination.
