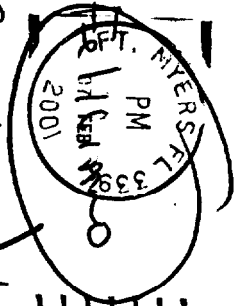

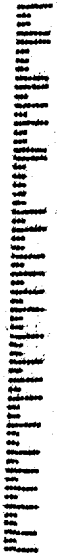

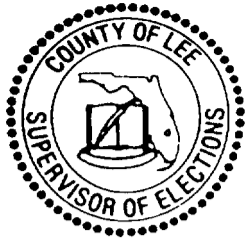

Assessment of Fine for Late Filing

Dear Mr. Grottanelli:

It has been determined that it is necessary, pursuant to Florida Statute 106.07, to assess a fine for delinquent filing of Campaign Treasurer's Report (TR), due February 5, 2001. The report was received on February 8, 2001 bearing a February 7, 2001 United States post-mark. The fine is assessed as follows:

- A. Campaign Treasurer's Report, herein known as TR, was due on February 5, 2001 by 5:00 p.m. or appropriately post-marked 02-05-01 by the United States Postal Service. The period covered by TR was (11-03-00 through 02-05-01). This is a **90-day** termination report and the fine is based on FS 106.07 as follows: \$50 for each day late not to exceed 25% of total receipts or expenditures, whichever is greater, for the period covered by the late report. In compliance with FS 106.07 the fine assessed for TR is \$13.25. The fine is based on 25% of your expenditures for the period covered by the report.

The fine must be paid, from personal funds, within 20 days of receipt of this notice unless an appeal is made to the Florida Election Commission within the statutory **20-day** time period provided in Chapter 106.

Please refer to any of the following materials in your possession: Chapter 106 Florida Statutes, the 2000 Candidate Handbook on Campaign Financing, the 2000 Lee County Candidates Handbook and the 2000 Election Cycle Calendar of Reporting Dates for information regarding fine assessments and calculations.
