Primary Election: August 26, 2008

- ◆ **Early Voting** for the Primary Election will be from **Monday, August 11, 2008 through Saturday, August 23, 2008**. Early voting hours are Monday through Friday from 10:00 AM to 6:00 PM, and on Saturday from 9:00 AM to 5:00 PM. There is no early voting on Sunday. - ◆ **Initial Canvass Of The Absentee Ballots Received To Date** will take place **Wednesday, August 20, 2008 at 9:00 AM** in the Lee County Elections Main Office.
- ◆ **Canvassing Board Inspection Of Absentee Ballots Duplicated Due To Damage (if any)** will take place **Tuesday, August 26, 2008 at 1:00 PM** in the Lee County Elections Main Office.
- ◆ **Canvass Of Additional Absentee Ballots Received And Obtain Election Night Results** will take place **Tuesday, August 26, 2008 at 6:30 PM** in the Lee County Elections Main Office.
- ◆ **Canvassing Board Random Selection Of Precincts To Be Audited After The Primary Election** will take place **Tuesday, August 26, 2008** after all precincts report election returns to the Lee County Elections Office.
- ◆ **Canvass Of Provisional Ballots Received From Election Day (If Any)** will take place **Friday, August 29, 2008 at 9:00 AM** in the Lee County Elections Main Office.
- ◆ **Certification Of The Primary Election** will take place **Friday, August 29, 2008 at 9:00 AM** in the Lee County Elections Main Office.
- ◆ **Commencement Of Manual Audit of Precincts Randomly Selected In The Primary Election** shall begin on **Wednesday, September 3, 2008 at 9:00 AM** in the Lee County Elections Main Office.
