Council members are elected by district [single-member]. The terms of council members shall begin on the date of the certification of their election. The candidate who receives the highest number of votes cast for the seat or for the office for which he or she is running shall be declared to be elected. In the event of a tie between the candidates for any seat in the general election, following a mandatory recount, another election shall be held on the earliest date that the run-off election can be conducted. The candidates receiving the equal votes shall be the only candidates on the ballot for the run-off election. The names of unopposed candidates shall not appear on the ballot. Each unopposed candidate shall be deemed to have voted for him or herself.
