Section 101.572(2), Florida Statutes

For all access sessions, attestations must be on file, authorized persons must be confirmed, and their names must appear on the Supervisor's access roster. A person not listed on the Supervisor's access roster will not be granted access.

Per Section 102.141(2)(a), Florida Statutes, each political party, and each candidate may have one <u>watcher</u> present at each meeting. County Canvassing Board meetings are open to the public.
